Please complete the items for sale part of the application. We do not offer exclusive rights to any food concession but we reserve the right to limit certain items so we do not have too much of certain items. All menus must be approved by the Fair Association thirty days prior to event date.

We need to receive all of the contracts and full payment by August 1st so that we know who will be returning this year.
